- .1 Q: Can a general contractor and fire protection contractor pursue this opportunity as an exclusive partnership, without formalizing it as a joint venture? The intent is for the general contractor to act as the prime and fire protection contractor as a subtrade partner.
 - A: The described arrangement appears to be in line with the general contractor-subtrade arrangement noted in the specifications. All reference projects provided should include both the general contractor and sub-trade partner.
- .2 Q: Linear ceiling system removal standard practice to remove full lengths for re install based on 1200 mm corridor passage at all times this will be unattainable. Please review requirements related to infection control and required egress.
 - A: Full lengths of the linear ceiling system are to be removed to accommodate the proposed works. Hoarding is to be constructed to maintain egress and meet the requirements of CSA Z317.13.
- .3 Q: Alternate price to remove existing slat ceiling mains would be ran from one side of the corridor to the other. Providing a 1200mm corridor passage at all times is not viable for proper installation.

A: It is expected that this will be a multi-day event. These details will be discussed during the construction kick off meeting.

.6 Q: A1-120 "1/A1-120 attic plan const note 3 – no detail or material type noted. No path of travel identified. Please provide detail for walkway construction and identify expected path of travel including start/stop. Also please identify if there area areas that a larger platform may be required such as roof access hatches. If larger platform is required please identify sizing and provide construction detail

A: The walkway is for contractor access and material loading. It is to be provided to assist in construction of the attic sprinkler system only and should be left in place at the completion of construction. Coordinate extent with main sprinkler runs, roof attic access hatch. Walkway is to be constructed of 50mm x 200mm dimensional lumber refer to the phasing key notes for additional details.

.7 Q: M1-001 – laydown location provided and noted but no location noted for site office and washroom facilities. Please identify acceptable location and connection point for temporary electrical services.

A: These details will be discussed during the construction kick off meeting.
